ORGANIZATION OPERATES A REGIONAL ANIMAL SHELTER TO HOUSE AND CARE FOR STRAY AND UNWANTED ANIMALS UNTIL THEY CAN BE PLACED FOR ADOPTION OR IN SOME CASES EUTHANIZED. IN 2012 THE ORGANIZATION TOOK IN APPROXIMATELY 43,000 ANIMALS. OF THE ANIMALS HOUSED IN 2012, 27% WERE ADOPTED/RESCUED, 61% WERE EUTHANIZED, AND 11% WERE RETURNED TO THEIR OWNERS.
