IN 2010 THE ORGANIZATION TOOK IN APPROXIMATELY 49,000 ANIMALS. OF THE ANIMALS HOUSED IN 2010, 21% WERE ADOPTED/RESCUED, 61% WERE EUTHANIZED, AND 10% WERE RETURNED TO THEIR OWNERS.
